**ORDER GRANTING STATE OF FLORIDA'S UNOPPOSED MOTION
FOR ENTRY OF ORDER MODIFYING INJUNCTION**

THIS CAUSE is before the Court on the State of Florida's Unopposed Motion for Entry of Order Modifying Injunction, filed on October 16, 2024. (DE 1231). The State of Florida seeks this modification consistent with my Order of indicative ruling under Fed. R. Civ. Pro. 62.1, issued on September 6, 2024, in which I stated that I would grant the State's request to strike Part II.C. of the Injunction if the Court of Appeals were to remand the case for that limited purpose. (DE 1227).


The Motion provides that on September 20, 2024, the Parties jointly requested the Eleventh Circuit to remand on a limited basis to authorize this Court to modify the injunction in the manner described in the indicative ruling. On October 11, 2024, the Eleventh Circuit granted the Parties' motion. (DE 1230). Now, the State of Florida files this Motion for Entry of Order Modifying Injunction. The United States does not oppose.

Based upon the foregoing, it is **ORDERED AND ADJUDGED** that:

1. The State of Florida's Motion to Modify Injunction (DE 1231) is **GRANTED**.

2. The Order Modifying Injunction shall be entered separately.

ORDER MODIFYING INJUNCTION

On September 6, 2024, this Court issued an indicative ruling, consistent with Federal Rule of Civil Procedure 62.1, that it would grant the State of Florida's request to strike Part II.C. of the Order of Injunction (DE 1171) if the court of appeals were to remand the matter to this Court for that limited purpose. On October 11, 2024, the court of appeals granted a limited remand to authorize this Court to effectuate its indicative ruling. Accordingly, this Court modifies the Order of Injunction as follows: Part II.C. is hereby **STRICKEN**, and the State of Florida is relieved of any obligation to comply with that provision.

This modification shall take effect immediately. This Order does not modify or otherwise affect any other provisions of the Order of Injunction.
